

Letter from the Executive Director

Without question the 2020-21 fiscal year has been one of the most taxing periods in our region's history. The closing of the border, lost business opportunities, quarantines, lock downs, and a sense of not knowing due to the pandemic lead to personal and professional stress. In this annual report, I want to highlight some of the ways NMDC staff has helped alleviate some of that stress by leveraging state and federal programs to help the business community.

During the past year, NMDC has established partnerships with different levels of state government to provide pandemic assistance grants to more than 1,500 businesses and nonprofits. Seeing an opportunity to greater assist the business community, NMDC scrambled to become a Paycheck Protection Program lender through our Community Development Financial Institution designation. That decision helped over 200 businesspeople without strong ties to traditional banks and credit unions. Business counselors and loan officers at NMDC spent hundreds of hours walking applicants through the process of applying for assistance and as you'll see in the pages of this annual report, those efforts paid off significantly for Aroostook and Washington counties.

In addition to tackling the pandemic head on, NMDC continued to provide land use planning, tourism marketing, government contracting assistance and entrepreneurial development during the pandemic, even though our methods of engaging clients changed dramatically, thanks to Zoom and other videoconferencing platforms.

Northern Maine Development Commission envisions a treasured place with a vibrant quality of life and a thriving economy. The NMDC mission is to strengthen economic resilience for all communities in Aroostook and Washington counties through impact financing, technical assistance and collaborative planning.


Client Activity:

NMDC has 173 active clients in Aroostook County

We also service an additional 16 clients in the greater Millinocket/northern Penobscot County area

- In PY 21, services to our clients included:
- 610 individual counseling sessions
- Assisted 105 unique clients
- Added 15 new clients to the program
- Provided 782 hours of counseling time
- Assisted 3 companies in becoming SBA HUBZone Certified
- Conducted/participated in 14 workshops in Aroostook County, Millinocket area and via Zoom.
- Recorded \$16,500,000 in contract Awards for Aroostook County and Millinocket area small businesses, both primary and subcontracting Awards. These contracts included federal, state, and local agencies.

Scenic Byway Development



In 2020-21, NMDC staff worked to secure national scenic byway status for the Katahdin Woods and Water Byway and the above, St. John Valley/Fish River Byway. The St. John Valley/Fish River Byway is approximately 134-miles long and was designated for its cultural intrinsic resources.
